BURGLARS SWEEP THROUGH BROWARD

UPDATE 01.04.13

The Fort Lauderdale Police Department, Property Crimes Detectives later learned that Steers bonded out of the Broward County Jail shortly after this original release. Steers was actively evading police and refusing to attend his court proceedings.

On Thursday, January 3, 2013, Detectives were notified that Steers was in custody for unrelated charges and booked under a false name. Detectives were then able to additionally charge him with the following;

- 3 counts of Burglary of a Conveyance
- 1 count of Burglary of a Business
- 5 counts of Grand Theft
- 1 count of Dealing in Stolen Property
- 1 count of False Verification of Ownership

The Fort Lauderdale Police Department is investigating a business burglary that occurred during the late evening hours of Sunday, September 16, 2012. The burglary took place at the Rolly Marine Service, Inc. located at 2551 State Road 84 in the City of Fort Lauderdale.

A nearby business owner, Butch Risker of Universal Marine Center, located at 2700 Southwest 25th Terrace in the City of Fort Lauderdale, informed Fort Lauderdale Police Officers that he observed two unknown W/M suspects enter his fenced business on Sunday, September 16th at approximately 11:30 P.M. Surveillance footage recorded the burglars occupying Risker's golf cart and driving over to Rolly Marine Service. The burglars took two yellow shore power cords from the docks at the business and then used the golf cart to transport their stolen loot away from the property.

It has since been determined that these suspects are responsible for similar marine related burglaries throughout Broward County. The Fort Lauderdale Police Department, Property Crimes Detectives were contacted by Davie Police Department when they arrested a W/M, who was wanted for an unrelated burglary. This suspect was identified as William Steers, W/M, 02/12/81, a Fort Lauderdale resident. Further investigation revealed that Steers was involved in a

P.R.# 2012-088 OR# 12-106604 small burglary ring, victimizing maritime residents throughout the county. Two other suspects who joined Steers on his criminal voyage were Jonathan S. Bambino, W/M, 11/06/77, a Plantation resident and Jonathan Sulzer, W/M, 01/30/90, a Tamarac resident.

At this time, Fort Lauderdale Detectives have charged Bambino with Dealing in Stolen Property. Charges against the other named suspects are pending at this time.

Detectives believe this ring of burglars is responsible for approximately ten other similar burglaries throughout our City. Detectives are actively working these open cases with the assistance from detectives at Davie Police Department, Lighthouse Point Police Department, and the Broward Sheriff's Office Pompano and Deerfield districts.
