

CITY OF FORT LAUDERDALE DOWNTOWN COUNTDOWN 2014

The Downtown Countdown 2014 celebration will feature a variety of activities for the entire family beginning at 4:30 P.M. and ending at approximately 8:30 P.M. Those festivities will include bounce houses, face painting, games and contests, dancing with the DJ, and an early ball lighting countdown at 7:00 p.m. For the adult crowd there will be live music from 9:00 P.M. until 2:00 A.M.

The Fort Lauderdale Police Department will head the public safety and security operations for this event.

Parents are reminded to have discussions with their children, directing them to locate a uniformed police officer or fire rescue staff member should they become separated from their family.



- Wednesday, December 31st 7:00 A.M. to Thursday, January 1st 8:00 A.M.
 - ➤ Southwest 2nd Street will be closed from Southwest 7th Avenue to Southwest 1st Avenue.
 - ➤ Eastbound traffic on Southwest 2nd Street, between Southwest 7th Avenue and Southwest 5th Avenue, will be restricted to Broward Center for the Performing Arts employees and VIP / Valet customers. Employees and show attendees should utilize Southwest 7th Avenue, rather than Southwest 5th Avenue for access to the center.

- Southwest 5th Avenue will be closed from Broward Boulevard south to the New River.
- Southwest 4th Avenue and Southwest 3rd Avenue will be restricted to limited access from Broward Boulevard south to the New River. Access to these Avenues will be restricted to residents who live in the area and employees of nearby businesses.
- Southwest 2nd Avenue will be closed from Broward Boulevard south to the New River.

In an effort to manage the expected attendance for this event, Fort Lauderdale Police Department personnel will be stationed at all nearby intersections and crosswalks to assist with pedestrian and vehicular traffic, as well as throughout the event site.

The Fort Lauderdale Police Department reminds motorists to only park in designated parking areas, as any parking violations will be strictly enforced.

The City of Fort Lauderdale reminds taxi-cab companies to only use the designated locations for pick-ups and drop-offs. The taxi stand pick-up and drop-off lane will be the right eastbound lane of Broward Boulevard between Southwest 5th Avenue and Southwest 2nd Avenue. Only Broward County permitted taxi-cab companies can use this designated area. No independent car services are permitted to use this area for drop-offs or pick-ups.
