SHOOTING HOMICIDE

Update: 04.19.18

The Fort Lauderdale Homicide Unit has identified the homicide suspect related to the officer involved shooting incident that took place on Wednesday, April 18th at approximately 6:11 P.M. The incident occurred at 926 West Sunrise Boulevard in the City of Fort Lauderdale.

The homicide suspect has been identified as Dytadious Mobley, B/M, 9/22/1986, a resident of the City of Fort Lauderdale. Mobley was pronounced deceased on scene.

Detectives of the US Marshals South Florida Regional Fugitive Task Force observed the homicide suspect, Mobley, in the 900 block of West Sunrise Boulevard, at which time detectives attempted to make contact with him. The suspect refused to cooperate with the detectives and responded by discharging several firearms, multiple times, at the detectives. The detectives were forced to returned fire, striking the suspect. Detectives recovered two handguns from inside of the suspect vehicle.

The Fort Lauderdale Police Department is assisting the Florida Department of Law Enforcement in the investigation of the officer involved shooting incident.

The Fort Lauderdale Police Department is actively investigating the homicide of an adult female that occurred on Tuesday, January 16th at approximately 6:33 P.M. The incident occurred at 1812 Northwest 11th Place in the City of Fort Lauderdale.

Preliminary investigation has revealed a known suspect shot the victim several times in front of her daughter and 5 grandchildren. The suspect fathered three of the victim's grandchildren. The suspect fled the scene before police officers arrived on scene.

The victim was transported to Broward General Medical Center where she was pronounced deceased as a result of her injuries.

The victim has been identified as Bernice Jefferson, B/F, 02/16/1962, a resident of the City of Fort Lauderdale.

First Degree Murder

Anyone caught assisting Mobley in avoiding his apprehension will be subject to felony arrest.
