FLPD NEEDS TO IDENTIFY SERIAL RETAIL THEFT SUSPECTS

UPDATE 2.15.2021: After further investigation, detectives have determined there are more than three suspects involved in these incidents. As a result of numerous tips, detectives have identified three of the suspects as the following:

- Luis Angulo-Montalvan, H/M, DOB 11/1/1994, a resident of Miami-Dade County.
- Juan Rodriguez Rivero, H/M, DOB 2/28/1990, a resident of Miami-Dade County.
- Yordan Soublett, H/M, DOB 2/7/1993, a resident of Miami-Dade County.

All three suspects have been arrested and charged with Grand Theft.

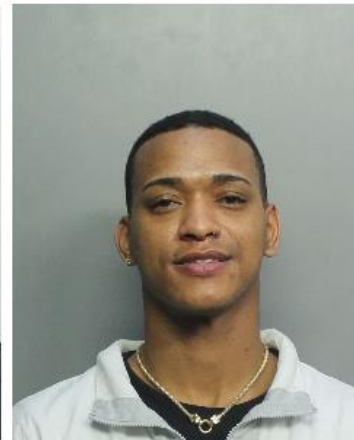

ORIGINAL 12.18.2021: The Fort Lauderdale Police Department is investigating a series of retail thefts that have occurred in the downtown sector of the city of Fort Lauderdale. Detectives believe the same suspects may be responsible for three separate incidents occurring on: Thursday, August 27th; Tuesday, December 1st and Monday, December 7th.

Preliminary investigation has revealed the group of three suspects work together targeting high-end clothing and watches. The suspects victimized two Fort Lauderdale businesses along East Las Olas Boulevard with a total loss of nearly \$100,000 in merchandise.

The suspects are described as hispanic males between 20 and 30 years of age.

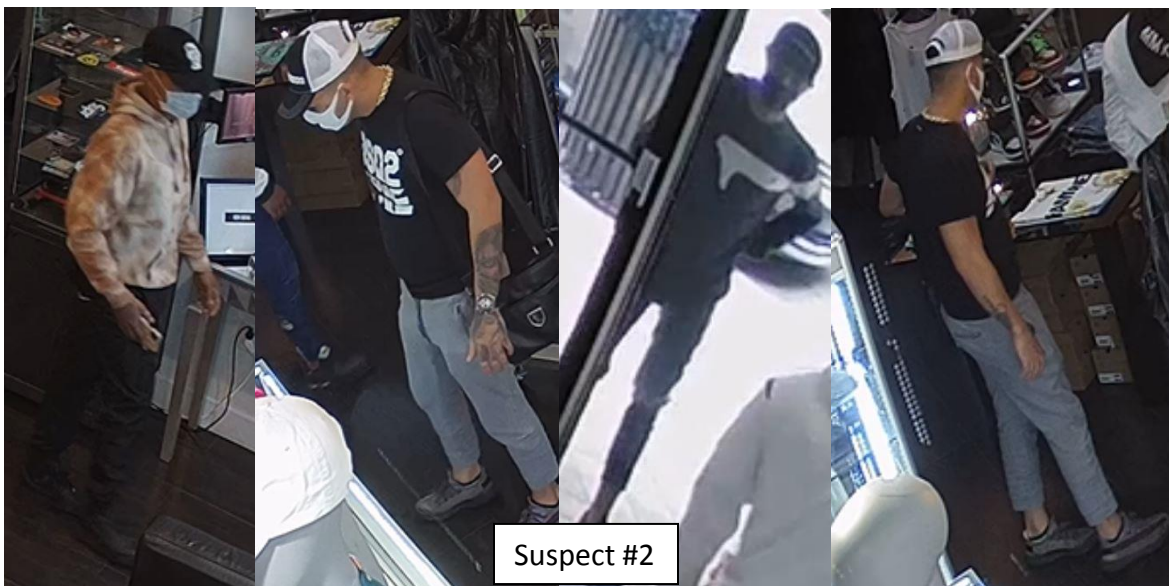
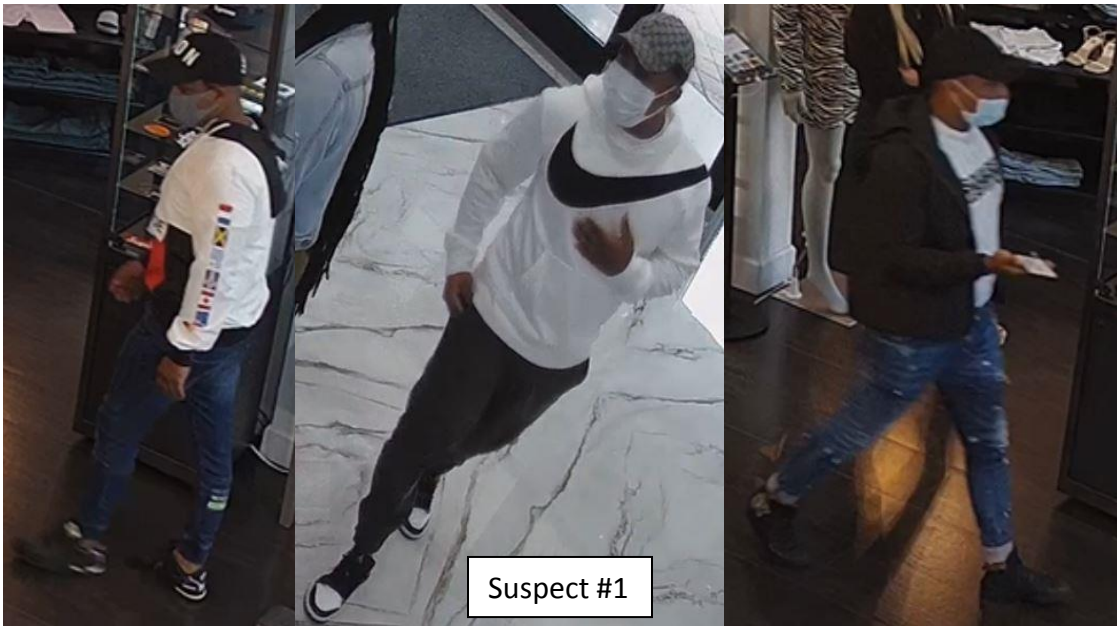

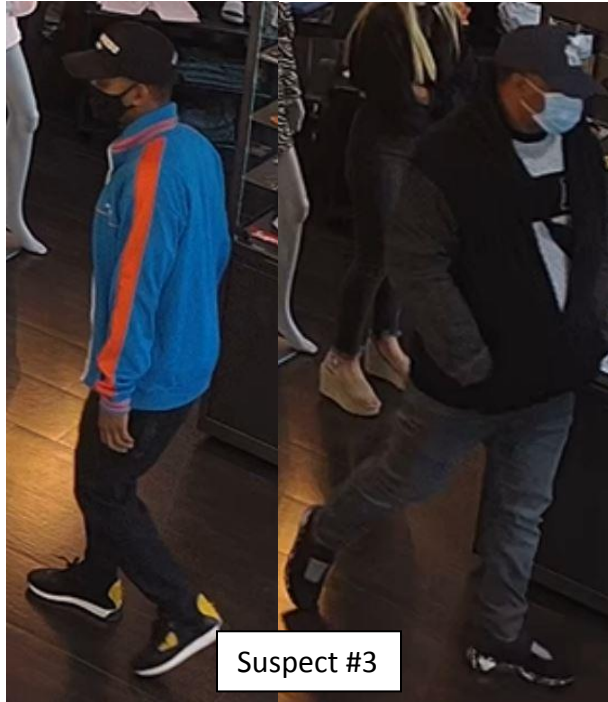
