Captain Adam Solomon

Adam Solomon joined the Fort Lauderdale Police Department in January 2006. He began his career serving in the Operations Bureau as a patrol officer and in the Criminal Investigations Division where he served as a detective in both the Property Crimes Unit and the Violent Crimes Unit.
