Major Patrick Hart

Patrick Hart has served the Fort Lauderdale Police Department since 1997. He began his career in the Operations Bureau as a patrol officer and later served as a member of the Tactical Impact Unit. He was also a member of the department's SWAT team for 12 years and the Bomb Team Commander for 10 years. As Patrick rose through the ranks, he served in the Operations Bureau, Support Service Bureau, and the Office of the Chief. He also served at every level within the Investigations Bureau and ultimately led the Criminal Investigations Division as a captain. His most recent assignment was as captain of the Special Operations Division. Patrick holds a bachelor's degree in

criminology from Florida State University and a master's degree in criminal justice administration from Florida International University. He is a graduate of the Southern Police Institute's Command Officers Development Course and the Police Executive Research Forum. Patrick is the recipient of 19 departmental commendations and 30 public commendations.
